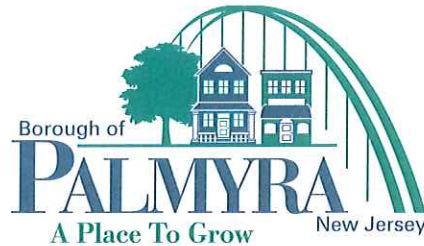

Dear Neighbors,

As some of you may know, the Borough has tried for many years to secure grant funding to improve the area along South Broad Street between Park Avenue and Public Road, which has seen better days for far too long.

While it has taken us much longer than we had hoped, I am now very pleased to report that we finally did it – the Borough of Palmyra was just awarded \$196,000 from the New Jersey Department of Transportation to make significant improvements in your neighborhood that include new curbing, driveway aprons, sidewalks, drainage improvements, parking, and a total reconstruction of South Broad Street from Park Avenue to Public Road.

You should also know that while we were awarded \$196,000, the actual total cost for all improvements is estimated at \$396,000, but that Borough Council has agreed to fund the entire balance of the project!

I would also be remiss if I didn't mention that Palmyra resident and our own State Assemblyman Troy Singleton was very instrumental in winning this award for Palmyra. Much thanks and our deep appreciation for Assemblyman Singleton's efforts!

Please see a copy of the award letter attached and please look forward to these improvements beginning in late fall of this year.
