REDEVELOPMENT

Rt. 73 South Redevelopment Area- Project Update

Mr. Valessi indicated the site work is continuing at the project and they are also working on storm sewer installation and concrete installation. Mr. Valessi indicated the redeveloper is requesting a certificate of acceptance, different than a certificate of occupancy or Temporary certificate of occupancy due to legal obligations. Mr. Valessi indicated they would be requesting it around November 15th, 2022. Mr. Gural asked Mr. Brewer if the redeveloper was obligated to begin payments on the pilot if the certificate of acceptance was issued. Mr. Brewer indicated no. Mr. Rosenberg indicated there could be problems and the engineer should work closely with Mr. Brewer as to the issuance of the certificate of acceptance. There was some additional discussion regarding the significance of the certificate of acceptance.

Outlaw Training & Fitness/620-622 Highland Ave Redevelopment Project – Update

Mr. Brewer indicated the Outlaw Investment Group; LLC will be before the Land Use Board next week. Mr. Rosenberg asked Mr. Brewer what the status of the additional funding due was for Outlaw fitness. Mr. Brewer stated that Outlaw has indicated they are ready to proceed. Mr. Brewer noted some additional requirements regarding tax payments and amounts. Mr. Gural indicated he would talk to Ms. Johns regarding the over payment or payment made to their tax account.

Elm Office LLC, 321 E. Broad Street Project -Update

Mr. Brewer stated the draft redevelopment agreement is with Elm Office, LLC and he is waiting for comments from them for final preparation of the agreement.

PROFESSIONAL UPDATES

William Kirchner, ERI

Mr. Kirchner explained the two resolutions on the agenda for approval. Mr. Kirchner indicated the Bird Dog is back on track however all the materials will not be available to start the Temple and Firth Lane portion of the reconstruction of Temple Blvd until sometime around Christmas weather permitting. Mr. Kirchner indicated that in accordance with the TAP Grant requirements we have until September of 2023 to have the project complete. Mr. Kirchner stated that on Wednesday and Thursday on this week a contractor will be in to jet vacuum out of the storm drains between Leconey Circle and Firth Lane due to there being about twelve inches of sand and grit in those drains. Mr. Kirchner noted that public works tried to clean them out, but our equipment is not able to handle that amount of debris. Mr. Kirchner noted a built up in an outlet on Parry which will be addressed in next year's budget.

PUBLIC EVENTS

Mayor Tait stated the following events will be taking place in the community.

Flu Clinic- October 27, 2022, at the Palmyra Community Center between 10:00 am and 12:00 noon.

Virtua Mobile Grocery Store comes every Thursday between 2:00 pm to 3:30 pm in front of the Community Center. Mayor Tait noted the Halloween Parade would be back in person down Broad Street on Sunday October 30th, 2022. Dr. Cloud noted the Beach sweep being held October 22, 2022, at 7:30 am beginning at the Palmyra Nature Cove.

DISCUSSION ITEMS

Mr. Gural stated the Republic has slightly improved their services however there are still problems. Mr. Gural noted the bid specs are out for the new solid waste disposal contract, we have purchased one trash truck which needs some repairs and intend to purchase to new trucks by years end.

Mr. Gural stated he was waiting for additional information from the attorney regarding the Fire Department program/proposed policy.

Mr. Gural noted he is reviewing the time clock/punch in/out requirements policy with the attorney and should have an updated policy for council consideration soon. Mr. Gural noted the Ms. Condo is currently making sure that all time clock equipment is working properly.

Mr. Gural stated he had nothing new to report regarding parking enforcement and noted that we do not have the staff to properly address it at this point.

Mr. Gural indicated a list has been created of the surplus vehicles which will be sold on govdeals.com.

Mr. Gural stated he would have the resolution ready for council consideration in the upcoming meetings. Mr. Gural stated council has authorized the purchase of several vehicles once the funding is available. Mr. Gural indicated the public safety committee should meet and discussion how we are proceeding regarding those purchases.

Mr. Gural indicated the sewer conversion to water-usage based billing is still a consideration for council, noting that if approved it would take place next year.

Mr. Gural stated that the public safety committee met regarding the PPA/FOP grievance, and they are currently awaiting additional information from the attorneys.

Mr. Gural stated the COVID-19 policy is not being followed. Mr. Gural asked council what they wished to do with new hires. Mr. Gural indicated the current policy requires new hires to be vaccinated. After some discussion council decided the policy would remain in place as it currently is, and they would continue to monitor the situation. Mr. Gural stated he would send the current policy to the governing body so they could review it to make changes.

There was discussion regarding staffing the community center. It was decided the Borough would advertise, take applications, and look at the possibility of hiring a cleaning service to clean the building especially the gym on a daily basic. Mr. Gural indicated he would put together some numbers and report back.

Mr. Gural stated the RFP/RFQ proposals requests will be going out next week.

Mr. Gural stated this is the first week the Public Works & Sewer CDL licensed employees will see the increases in their pay. Mr. Gural noted that Mayor Tait had reached out to Mr. McGill regarding getting the other employees obtaining their CDL licenses noting that when they get them, they too will be entitled to the increase in pay.

Mr. Gural indicated that the Girl Scout Troop 23750 had reached out with a request to place a collection container in Borough Hall to collect clothes and food for the needy. Council agreed it would be ok for them to do.

ADMINISTRATORS REPORT

Mr. Gural stated that after extensively looking into the Health Insurance Fund, that we currently are not able to get into that program or any other program of that type.

Mr. Gural indicated that the trails grant will be affected by the eagle's nest so it does not make sense to apply for that grant this year, if all goes well, the restriction regarding the eagle's nest is lifted, we should be able to apply next year.

Mr. Gural indicated, for your information, the report of tax sale was emailed to everyone earlier in the day.

Mr. Gural indicated the best practices checklist is due November 10th. 2022. Mr. Gural noted that because the meeting is an early meeting and a shorter meeting due to the election being the next day, the best practices checklist will be presented at the following meeting but will be submitted as required by November 10th, 2022.
