This will be issued on the basis that all information provided on this application is correct and agree that all construction and uses will comply with the Borough of Palmyra Master Plan and Zoning Ordinance. Violation of any of these ordinances or laws shall result in revocation of the permit. The Board may revoke the permit in the future if the Board finds that such permit was obtained by fraud; that one or more of the terms or conditions upon which such permit was granted has been violated; or that the use for which the permit was granted is so conducted to be detrimental to the public health, safety, or general welfare or as to be a nuisance. The applicant shall allow the Borough of Palmyra representative(s) or designee(s) to make periodic inspections at any reasonable time deemed necessary to assure that the activity being performed under authority of this permit is in accordance with the terms and conditions prescribed within. No additional buildings, fences, sheds, slabs, or other facilities have been constructed, installed or otherwise located on the property after the date of the legal survey submitted with this application. ANY AND ALL STRUCTURAL WORK ON THE PROPERTY WILL REQUIRE A CONSTRUCTION PERMIT. By my signature, I certify that I have read and understand the conditions of this permit.
