REDEVELOPMENT

Rt. 73 South Redevelopment Area- Update

Mr. Gural indicated substantial completion is anticipated on the first warehouse on the southside of Rt 73. Mr. Gural stated that upon substantial completion we anticipate being eligible to receive the pilot payment. Mr. Gural noted that in accordance with the current schedule the redeveloper should have substantial completion by December 16th, 2022; noting that if it occurs that we will be able to anticipate as much of that pilot payment revenue in the 2023 budget.

Mr. Brewer indicated he had nothing additional to add.

Mr. Valesi stated the redeveloper is moving along, noting the following things are still outstanding; retaining wall construction, concrete flat work, access to trailer parking within the building itself, landscaping, and operational street lighting. Mr. Valesi indicated they would continue to monitor the progress and report back to the Borough.

Outlaw Training & Fitness/620-622 Highland Ave Redevelopment Project — Update

Mr. Brewer noted the appearance of Outlaw Investment Group, LLC before the Land Use Board at their October 26th, 2022 meeting. Mr. Brewer noted the memorialization of their approval at the next Land Use Board meeting. Mr. Brewer stated they are working on the wording of the settlement of the litigation. Mr. Brewer indicated he is working with Outlaw regarding the \$10,000.00 loan, noting that the litigations should be finished shortly.

ELM Office LLC, 321 E. Broad Street Project- Update

Mr. Brewer stated the Mayor had signed the final version of the redevelopment agreement, which he forwarded to ELM Office, LLC and we are waiting for their signature. Mr. Kirchner indicated he needed some sort of site plan to determine exactly where the easement will be needed for the sign. Mr. Kirchner noted no site plan has yet been submitted. Mr. Brewer noted they agreed to allowing for the sign on the property.

PROFESSIONAL UPDATES

William Kirchner, ERI

Mr. Kirchner explained the two resolutions on the agenda for approval. Mr. Kirchner noted the completion of the 2022 Road Improvement program is complete aside from a few minor punch list items. Mr. Kirchner indicated we would pay the contractor and hold retainage until February or March to make sure there is no problem with ponding or issues on those roads. Mr. Kirchner stated he has collected all the information from the contractor of firth and temple project noting he is waiting for two more items and then he will ready to schedule the subcommittee meeting with Councilwomen McCann and Cloud regarding the park amenities.

Mr. Bauer – Cinnaminson Avenue – Mr. Bauer indicated he still has blinding lighting coming from his neighbor's house. Mr. Bauer indicated he had spoken with the code enforcement officer several times and is waiting for his to get back to him regarding the lights. Mayor Tait indicated they would have Mr. Bellinger get in touch with him again.

Ms. Holloway – Broad Street – Mrs. Holloway noted the decorative street lights have been out for about seven months. Ms. Holloway stated she just wanted an update as to when they would be fixed. Mayor Tait indicated she had spoken with a rep from PSE&G and they were looking into it noting that she would follow up with them and get back to her. Mr. Gural stated the Borough paid for the lights but they are PSE&G's responsibility to maintain. Mr. Gural indicated he would look into it also. Mrs. Holloway indicated that public works did come down and weed whack the ground level but it still

needs to be cut at the top/ on the sloop. Mrs. Holloway also asked it was possible to cut down the trees down from Rt 73 to Orchard Avenue. Mr. Gural indicated he would look into it but he believed the trees do not belong to the Borough but are in the railroad right-of-way on a county road. Mr. Gural indicated he would look into it and get back to her. Mrs. Holloway asked about the Rodger Wilco property and the need for it to be clean up and the trees cut down. Mrs. Holloway indicated she has asked about that property being cleaned-up before and was told violations would be issued, but nothing has been done with the property. Mr. Gural indicated he would notify code enforcement regarding the matter, however if notices were or were not issued in the past, he had no knowledge and would have to follow-up with the code enforcement officer to find out. Mrs. Holloway asked when the next meeting was. Mayor Tait indicated December 5th, 2022.

BEST PRACTICES INVENTORY PRESENTATION

2022 Municipal Best Practices Inventory Presentation

Mr. Gural went over the 2022 Best Practices Inventory commenting and noting our responses for each item. After noting the responses to the various questions on the 2022 Best Practices inventory questioner he asked if there were questions regarding our responses. Mr. Gural indicated it was forwarded to the state by the required deadline, and our answers and score 31.5 make the Borough eligible for the full amount of state aid available.

DISCUSSION ITEMS

Mr. Gural stated that we still have ongoing issues with Republic. Mr. Gural noted the opening of bids on December 1, 2022 for the new solid waste disposal contract. Mr. Gural explained the latest addendum to the bid specs for the new contract. Mr. Gural noted that the base bid does not include bulk trash. Mr. Gural noted the first of two new trash trucks will be delivered on Wednesday of next week noting that the plans for trash collection are a work in progress.

Mr. Gural indicated there was nothing new to report regarding parking enforcement.

Mr. Gural indicated was are working on the surplus vehicles listing.

Mr. Gural noted that was nothing new to report regarding vacation leave and accrual issues.

Mr. Gural stated the vehicle purchases were awarded earlies and he suggested we work on getting the new sewer truck.

Mr. Gural indicated the PPA/FOP grievance issues is resolved; we are waiting for final word.

Mr. Gural indicated he is working on the updated COVID-19 policy and will forward to council when amended for consideration.

Mr. Gural stated the lien holder is requesting that we sell/reassign our municipal lien on 400 Arch Street to them so they can foreclose on the property and either sell it or put a house on it for sale. Mr. Gural noted that we have about \$31,000.00 in liens on the property, we spent \$17,000.00 to take it down and the remaining balance is interest and taxes due on the land and we may never see those monies. Mr. Gural noted the lien holder is offering us \$20,000.00 to purchase the lien. Mr. Gural asked for permission to sell the lien for the offering. Council agreed to accept the offer.

Mr. Gural explained the need for a Certified Public Works Manager noting that we haven't had one since around 2018 when the last one left. Mr. Gural noted that municipalities of our size are required, after a number, of years to have a CPWM. Mr. Gural noted we have relied on our Engineering firm who holds most of those credentials to fill the void. Mr. Gural noted that he is seeking permission to hire advertise for a CPWM. Council agreed.

Mr. Gural indicated the Chapter 92 – Liability Insurance for Business Owners/ Rental unit Owner's statue is in the packet, he noted that Mr. Rosenberg may be able to explain more. Mr. Rosenberg stated he had just looked it over but would ask for additional time to review and report back to the governing body.
