Rt. 73 South Redevelopment Area

Mr. Rohmeyer stated the redeveloper has requested a TCO with no occupancy. Mr. Rosenberg explained that this was agreed upon by the governing body previously, however the adoption may have been informal and not done by resolution. Mr. Rosenberg explained that we have been asked to adopt by resolution, formally, the Borough's commitment to that \$250,000.00. Mr. Rosenberg noted that the \$250,000.00 would need to be placed into the trust fund when the settlement agreement is signed, noted also that it would be the very last funding in the trust fund to be used. There was some additional discussion.

Mayor Tait stated the Virtua Mobile Grocery Store is still in town on Thursdays from 2:00 pm to 3:30 pm in front of the Community Center.

Mayor Tait stated that Santa's visit and the Tree Lighting was held last Friday and it was a great time. Mayor Tait noted the Reorganization of Borough Council Meeting will be held on Friday, January 6th, 2023 at 4:00 pm.

DISCUSSION ITEMS

Mr. Gural explained the Solid waste disposal bid results noting the significant increase in pricing and the lowest responsible bidder, Republic Services. Mr. Gural noted the new contract begins on April 1, 2023. Mr. Gural noted contained in the meeting packets is last contracts pricing and the new pricing for the new contract. Mr. Gural explained the pricing difference and our intention to move forward with selective in-house collection. There was some additional discussion regarding bulk, pricing, and rejection of bids and rebidding.

Mr. Gural explained some of the issues facing public works department and noted that several very good applications had been received. Mr. Gural also noted the CPWM position is advertised, and we are accepting applications currently.

Mr. Gural stated that we own the decorative light poles from Rt. 73 up to Market Street not PSEG. Mr. Gural noted that Municipal Maintenance has been repairing and replacing light bulbs where need and the lights from Rt. 73 to Market are operational. Mr. Gural stated he is working with PSEG on the other decorative light poles on Broad Street from Market Street to Elm Avenue to get them up and on. Mr. Gural noted the Fourth Street Reconstruction Grant is for 4th Street between Delaware Avenue and Race Street.

Mr. Gural state that Ms. Kilmer has provided a report regarding state regulations for rental properties and Mr. Rosenberg is working on the new ordinance.

Mr. Gural noted the discussion regarding the Covid-19 policy and potential updates should be had in closed session.

ADMINISTRATORS REPORT

Mr. Gural stated the 2023 RFP/RFQ's are in, Ms. Jackson put together a listing of the responses which is included in your packets and thumb drives should also be on the dais which include copies of all the proposals submitted. Mr. Gural noted you can begin looking them over so appointments can be made at reorganization.

Mr. Gural stated that the NJDOT Technical Assistance Program- Pedestrian & Bicycle Project will be meeting next week on December 16th, 2022.

Mr. Gural reported the Fire Department stipend program ordinance was approved earlier tonight and will begin on January 1, 2023. Mr. Gural stated all those participating in the stipend program must be members of the Palmyra Fire department and must be appointed by council.

Mr. Gural explained the BANDS sold and how we were able to self-finance them, noting that we will earn 4% on the investment.
