# **REDEVELOPMENT**

Rt. 73 South Redevelopment Area- Update

Mr. Gural Stated the Borough was recognized by NJTP and other State Agencies for our Brownfields Redevelopment success story. Mr. Gural indicated the first warehouse project is in the final stages of completion noting that they are working on the punch list to obtain a permanent TCO. Mr. Gural noted the outstanding item which prevents them from obtaining the CO for the first warehouse, the electricity to the pump station. Mr. Gural stated they have begun clearing the site for the second warehouse. Mr. Gural stated the Sansone is working on a potential ground opening for the second warehouse. Mr. Rosenberg stated the application made by the affordable housing redeveloper was submitted to FHMA and they acknowledged that the application was complete. They are now looking at the financing to determine if the financing will be approved. Once this is complete, they can go to closing, the affordable housing redeveloper will then get the title to the property from the Borough.

Mr. Gural noted it currently reads must have served as a member of the police department for a minimum of 10 years and must have combined service as a sergeant or lieutenant for

at least 5 years. Mr. Gural noted that Mr. Rosenberg thought they were long periods of time and that the governing body may wish to consolidate that or change it. There was some discussion, and it was decided it would be 7 years and 4 years respectively.

Mayor Tait indicated that to attract more officers to the Borough of Palmyra Police Department, she would like to up the Police sign on bonus. Mr. Gural indicated that we are currently paying \$1,000.00 for someone who has no experience and \$2,000.00 for someone who has already completed the academy. Mr. Gural indicated that the bonus requires they commit to the Borough/Palmyra Police Depart for six years and if they leave prior to that time they do have to pay it back. Mr. Gural also noted that if changed it would need to be negotiated with the Police Association as it would affect the contract. There was some discussion, and it was decided to change it to \$2,000.00 and \$4,000.00. Mr. Gural noted that he had to speak with the Police Association but that the resolution could be voted on as it is currently, if the association was agreeable, it would be noted in the CBA.

#### **PUBLIC EVENTS**

Mayor Tait noted the following upcoming events.

Mayor Tait stated the Virtua Mobile Grocery Store is in the Community Center parking lot on Thursdays from 2:00 pm to 3:30 pm.

Mayor Tait the NJ Senior Olympics will be held September 8-10, 2023, in Woodbridge Township Mayor Tait noted the Townwide Yard Sale will be held September 16<sup>th</sup>, 2023. Ms. Latimore and Mrs. McCann indicated they would help with whatever needed to be done.

Mayor Tait noted that the YesWay Job Fair was being held August 22, 2023, and from 3:00 pm to 8:00 pm; from 3:00 pm to 6:00 pm is for Palmyra Residents only. The Job fair is being held at the site on Rt.73 South.

Mayor Tait noted the Palmyra Police Officers Association will be handing out backpacks and school supplies on the 31<sup>st</sup>, 2023 of August from 5:30 to 8:00 pm. Mayor Tait also indicated that a Summer Concert would take place simultaneously featuring the Big County & Finger Pick'n Good Band of which one of our officers is a part.

# **DISCUSSION ITEMS**

Mr. Gural stated that there had been discussions with Pemberton Township's court regarding a shared service agreement for the Deputy Municipal Court Administrator position. Mr. Gural indicated he is waiting for that feedback. Mr. Gural noted that we will be pursuing a temp service for fulfillment of that Deputy Municipal Clerk position.

Mr. Gural explained that we hired one person for the Community Center Staffing position and are looking at another potential seasonal employee depending upon the requested usage of the building. Ms. Donna Condo requested permission for attendance at the Government Finances Officers Association Conference in Atlantic City from September 26<sup>th</sup> thru 29<sup>th</sup>, 2023. A three-night stay is requested so permission is requested. The council agreed it was ok for her to attend and stay during the conference.

Mayor Tait indicated the NJLM Conference is in Atlantic City from November 14-16, 2023. If anyone on Council wishes to attend and stay overnight during the conference, please let Clerk Jackson know so accommodations can be arranged.

Mr. Rosenberg explained this was a proposed U.S. LIBOR-Based/Class Action Settlement suit. Mr. Rosenberg and Gural indicated that upon further research it was noted that Palmyra did not have those investments, so no further action is needed.

Mr. Gural indicated that the YMCA Summer Camp was completed on Friday. Mr. Gural noted that they are cleaning up, packing, and removing their things from the building for the next two days and will have the bike trailer removed from the lot on the 28<sup>th</sup> of August. Mr. Gural indicated it was a great camp and the children enjoyed it. Mr. Gural indicated they would be having a wrap up meeting with the YMCA on Wednesday.

Mr. Gural stated the Seniors are again trying to put their program together. Mr. Gural noted they are in the process of obtaining their 501C3 status/certification so we can process their requests.

Mr. Gural indicated he would have the sewer salary guide by September.

Mr. Gural indicated that tomorrow will be the sixth week of Trash collection in the Riverfront. Mr. Gural indicated all is going well and Mr. Gerbe, our primary collection agent, was present at the meeting. There was some discussion regarding the process and how it has been going. Mr. Gural indicated we now have an application you can download to your phone to keep up with the trash collection schedule and schedule bulk trash pick- up. Mr. Gural thank Ms. Johns for all her efforts in getting that application up and running. Mr. Gural stated the coupons program is going very well and several coupons have been presented from various businesses for redemption. Mr. Gural indicated that partnership with the local businesses is going very well. Mr. Gural stated that a meeting was held with Republic last week regarding the trash contract and how it is being handled. Mr. Gural indicated that if Republic continues to miss pick-ups, we will continue to apply liquidated damages as the contract indicates. Mr. Gural also noted during that meeting our desire to potentially move into Zone one as quickly as possible, with our in-house trash collection. Mr. Gural indicated he wanted to wait until we acquired the additional truck. Mr. Gural indicated that ninety-day notice could be going out last November or early December. There was some additional discussion.

Mr. Gural stated the artificial turf field replacement is underway, and we are looking at completion by September 10, 2023.

Mayor Tait indicated the people who have been working on the Bicycle & Pedestrian Planning Study Team were present at National Night Out and spoke with many, many people. Mr. Gural stated the study should be complete by early September and we are hopeful that it is going to support our desire to build a pedestrian/ bicycle bridge from the light rail station across the creek to the redevelopment area. Mayor Tait asked if the committee had reached out to Pennsauken Township. Mr. Gural indicated he did not know.

Mr. Gural indicated that we received an email regarding the upkeep of the Downtown area. Mr. Gural indicated he had forwarded it to the governing body. Mr. Gural indicated that the public works crew picks up trash twice a week, he noted that the businesses must be responsible for the areas in front of their business as homeowners are responsible for the area in front of their homes. There was additional discussion. Mayor Tait noted the new trash containers, that match, in the downtown area. Mr. Gural indicated what needs to happen is enforcement by both code enforcement and our class one officers. Dr. Cloud asked if public works could give some attention to the flower beds in the downtown area. Mr. Gural indicated he and Mr. Berg had spoken about it. There was some discussion regarding parking and enforcement in the downtown area. There was a discussion regarding the traffic and speeding on Delaware Avenue.

# ADMINISTRATOR'S REPORT

Mr. Gural stated that Part 2 of the Wizer 2023 Cyber Awareness Training is available and needs to be completed.

Mayor Tait indicated she would contact Cinnaminson Township and see what their plans are.

Mayor Tait asked Mr. Gural and Mr. Rosenberg if there were items for the closed session. Mr. Gural and Mr. Rosenberg indicated no.
