PROFESSIONAL UPDATES

William Kirchner, ERI

Mr. Kirchner went over the resolutions on the agenda for approval. Mr. Kirchner stated he received complaints regarding mosquitos in an area in the rain garden, he noted that they have treated the standing water and will be installing additional plants in that area. Mr. Kirchner indicated the spoke with Mr. Gural regarding the EV charging station in front of the Borough. Mr. Kirchner indicated Mr. Gural will be contacting PSEG regarding the installation and pricing. Mr. Kirchner indicated the grant is for \$55,000.00 which should cover the charging station but was unsure if it would cover the cost on the installation. Mr. Kirchner stated the G-Max testing on the new turf field has been completed and he is waiting for the results. Mr. Kirchner stated the grooming brush has also been ordered for the turf field. Mr. Kirchner indicated he met with Mayor Tait, Mr. Gural and others regarding the community garden grant and would have additional information regarding the expansion design at a later date. Mr. Kirchner stated he did an inspection of the tennis courts and the basketball court at Legion Field. Mr. Kirchner noted the tennis courts are in good shape, noting a few cracks which he felt could be filled and then the courts could be micro-surfaced with new coloring. Mr. Kirchner indicated the basketball court is a little wavey so it would probably need the same resurfacing as Ethel B Hardy Park. Mr. Kirchner stated he would put together some pricing and get it back to the governing body so a decision can be made as to how you wish to proceed. Mr. Liebe asked if additional benches could be installed at the tennis courts. There was some discussion and Mr. Kirchner indicated it could be done by the same contractor.

BEST PRACTICES INVENTORY PRESENTATION

2023 Municipal Best Practices Inventory Presentation

Ms. Condo presented the 2023 Municipal Best Practices Inventory. Ms. Condo noted the fifty-seven questions asked and indicated our total score was 39.50, higher than the required score to receive full state aid available. Ms. Condo noted that the Best Practices Inventory questionnaire needed to be filed with the state by November 3rd, 2023, and that ours would be filed before the end of the week. Ms. Condo also noted that the questionnaire will also be posted on the website after it is sent to the state.

Mayor Tait asked for a motion to open to the Public for comments President Howard made a motion to open the public portion for comments. Mrs. McCann second the motion.

Mrs. Nowicki - Morgan Avenue — Mrs. Nowicki asked who was in charge of the Geen Team. Dr. Cloud indicated she was. Mrs. Nowicki asked if the Borough would be doing the Trex Challenge. Dr. Cloud indicated she was not aware of it. Mrs. Nowicki explained, and Dr. Cloud indicated she would look into it. Mrs. Nowicki indicated she was tired of the negativity and would like to say a few things; she stated she has been to public works a couple of times lately, noting Alan Berg noting that they were courteous, friendly and very helpful; Linda Yansick always returns her calls and emailed in a timely manner and to is very pleasant; Mr. Benson from the sewer department has been out he also was very pleasant; Rita has been wonderful helping with the Senior program. Mrs. Nowicki indicated she stopped in and spoke with the Acting Chief and he spent a lot of time with her, very focused and interested in what she had to say and shared some ideas with her. Mrs. Nowicki indicated she has not had any negative experience with the employees of the Borough but had found them to be very courteous and helpful. Mrs. Nowicki thanked Mayor Tait and Council President Howard for setting a good example. Mrs. Nowicki stated she wanted to send a thank-you out to the Borough employees from someone who lives in town and appreciates their efforts.

Ms. Arnold - Oregon Avenue - Ms. Arnold asked about resolution 2023-241 the purchase of the refuse truck in the amount of \$390,726.40. Ms. Arnold asked what the expected return was on the investment? Mayor Tait indicated that ultimately it would allow us to reduce the cost of our trash collection and bring it in-house. Ms. Condo indicated she did not have exact numbers, however the ability to bring the collection in-house will in the long term allow us to save money. Ms. Condo Also noted that this truck will allow us to have a back=up in the events there is a problem with one of our other trash refuse vehicles. Ms. Condo also noted that in-house collection is also about service and having the trash pick-up on the schedule set not just randomly as is the service we are currently receiving from our contractor. Ms. Arnold asked how many zones there are currently. Ms. Condo

indicated four and the Riverfront. There was some additional discussion. Ms. Arnold asked where we are with the selection of a Chief of Police. Mayor Tait indicated the ordinance has been passed and procedures are in place, after the required estoppel period the public safety committee will meet and make the necessary notifications to the clerk. Ms. Arnold asked what is being done to curtail the activity at 5th and Race Streets. Lt. Murphy indicated they are working on various things which he cannot discuss, he indicated he has sent officers down there to sit in that area and observe and during the 10 hours they were present there was zero activity. There was additional discussion.

Mrs. McCray- Broad Street - Mrs. McCray indicated she was excited about moving to Palmyra and bought the house on the corner of Broad and Market Street. Mrs. McCray indicated she received a letter last week indicating their taxes would be more than doubling, she indicted she was disabled, and her husband is retired. Mayor Tait indicated she had spoken with her husband earlier in the day and asked if they had spoken with the assessor. Mrs. McCray indicated they had, and he indicated the taxes increase was due to the renovations which had recently been completed and the increase in value of the home. Mrs. McCray noted several things that are wrong with the house. Mrs. McCray indicated there is a train that runs in front of the house at night that they were not aware of and that there is a bus stop on the corner that they did not know was there. Mrs. McCray stated she recently spoke with the police and that there is a half-way house located in the back of her home that she did not know was there. Mrs. McCray stated the entire experience has been disheartening. Mr. Rosenberg stated that we feel your pain, noting that is a horrible set of facts which you have relayed to us. Mr. Rosenberg stated that you may have the ability to file a lawsuit against the responsible parties which sold you the house regarding the condition of the house. Mr. Rosenberg explained that the governing body has nothing to do with the transaction/purchase of the house, that is between the buyer and seller with help from realtors. Mr. Rosenberg noted the governing body does not control the tax assessor, he is independent and does not answer to the governing body. Mr. Rosenberg indicated that you could file an appeal of the assessment. There was some additional discussion.

Seeing no one else wishing to make a comment, Mayor Tait asked for a motion to closed to the public for comments President Howard made a motion to close the public portion for comments. Ms. Latimore second the motion.

Mr. O'Neil- Leconey Avenue — Mr. O'Neil asked if any decision had been made regarding getting the kids to school that will be living in affordable housing units. Mayor Tait indicated that a decision has not been made but that we will be talking with the school board regarding the matter. Mr. O'Neil stated that the Borough will need to create a crosswalk over Rt. 73 so the kids can walk to school. Mayor Tait indicated that the Borough will not be creating a cross over walkway. Mayor Tait indicated the school district will be responsible for getting the children to school. Mayor Tait indicated to find out more about how they intend to handle that you would need to attend the School Board meetings. Mr. O'Neil stated that the Chief should be named soon. Mayor Tait reminded all that this public session is for comments or questions regarding Ordinance 2023-18 only.
