LAND USE BOARD MEETING MINUTES

September 27th, 2023 at 7:00 PM

CALL TO ORDER

The Borough of Palmyra Land Use Board meeting was called to order by Land Use Board Chairman Lewis Yetter at 7:00 pm.

BOROUGH COUNCIL UPDATES

Mayor Tait noted that the Halloween Parade will be held on October 30th, 2023. Mayor Tait noted that the Board of Education had moved into the back of the Community Center. Mayor Tait also stated that the redeveloper had broken ground on the second warehouse of the Rt 73 Redevelopment Project.

NEW BUSINESS

Amending the Master Plan to include the Housing Element and Fair Share Plan

Mr. Brewer explained the need to amend the Master Plan to include the Housing Element and Fair Share Plan. He noted that the Fair Share Housing requested the Borough of Palmyra include the Housing Element and Fair Share Plan in the Master Plan, so as part of the settlement agreement the Borough of Palmyra agreed to include it and is requesting the Land Use Board review and adopt the Housing Element and Fair Share Plan amendment to the Master Plan

Mr. Brewer then swore in Dave Gerkens, Borough of Palmyra Planner.

Mr. Gerkens stated his credentials noting that the Master Plan was last updated in 2020. He explained that the Housing Element and Fair Share Plan was not included at that point. Mr. Gerkens explained there is nothing new, no changes to the existing Master Plan, just the adding of the Housing Element and Fair Share Plan which denotes the demographics, housing stock of the Borough of Palmyra. Mr. Gerkens stated it also includes statistics regarding employment and our capacity for Fair Share Housing. Mr. Gerkens explained the Fair Share Plan noting the 102 affordable rental units planed. Mr. Gerkens noted that those units must be completed by 2025 but the redeveloper is hoping to have the construction mostly complete by 4th quarter of 2024. Mr. Gerkens stated the redeveloper has the financing in place and is looking to break ground in October. There was some additional discussion between the Board and Mr. Gerkens.

Mr. Brewer noted, Resolution 2023-12 Adopting the Housing Element and Amending the Master Plan to include the Housing Element for the Board's consideration.

Chairman Yetter then requested a motion to open to the public for comment.

Vice-Chairmen Beck made a motion to open to the public for comment. Mayor Tait second the motion.

All members present voted in favor of the motion.

Seeing no one wishing to make a comment Chairman Yetter requested a motion to close the public comment.
